## Immigration White Paper – A Time for Prayer and Awareness

#### Introduction

In May, the UK government released a new Immigration White Paper proposing a series of changes aimed at reducing migration. Among the proposals is a significant shift from the current '5+1' route to settlement – five years of residence before applying for Indefinite Leave to Remain (ILR) and one year of residence before applying for citizenship – to a much longer '10+1' pathway. If adopted, this would greatly extend the journey toward settlement for many migrants. And the White paper does not specify how such changes would affect the British National (Overseas) (BNO) humanitarian visa route.

Other proposals include raising the income threshold for family visas, limiting dependants in certain visa categories, raising English standards and placing further restrictions on care worker sponsorships. These changes, though, may go for consultation and could create additional challenges for individuals and families seeking to build a stable future in the UK. ### **BU Response**

Thank you for a rapid response from our Baptist family. The Revd Lynn Green, our General Secretary, has signed a letter written to the government as a group of faith leaders to express their deep concern about the language used in recent discussions around migration.

In the letter, it urged policymakers to adopt a more respectful and constructive tone - one that recognises the dignity of all people and supports a more inclusive national conversation. They call for policies that balance the needs of host communities with compassion for those seeking safety and a new life in the UK.

They asked the government to speak with greater care, truth and compassion as well. They urged them to recognise the dignity of every person - whether born here or newly arrived - and to promote policies that are just and respectful to all. Here's the letter.
